The wonderful North East Staff and I feel privileged to be able to provide programs to your child and are especially proud of our summer day camp.

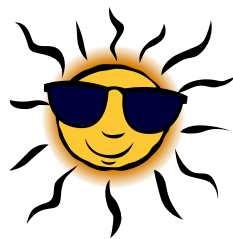

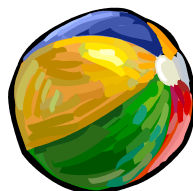
Dear Parents:

Fees:

In the past, we charged \$825.00 for our summer camp program. Due to the Medicaid conversion, we are only able to charge \$735.00.

We are sensitive to the needs of our families and have made payment plans and limited scholarships available (for North East residents only). Inquire at the North East office, as soon as possible if you would like to discuss a payment method with our Executive Director

REGISTRATION INFORMATION

To register for our 2021 Camp Program, please complete the enclosed registration form as appropriate:

New Campers:

New campers must schedule an intake interview with North East staff prior to registering for camp. Please complete the registration form enclosed with special attention to the section for new campers. Once we receive this form, we will contact you to start the intake process.

Returning Campers:

Former campers may use the enclosed form with attention to the section for returning campers. The North East Participant Information Form must be updated every three years. You will be notified if you need an updated form.

A new medical form must be completed each year. Your child will not be able to start camp on June 28th if we do not have an updated medical and all other mandatory paperwork in our main office by June 23rd.

Our Camp fills quickly! In order to be fair to everyone, we have developed a very structured registration policy.

Registration Priority:

Residents of the twelve communities in the North East District enjoy a registration priority period until May 24, 2021. A deposit of \$400.00 will hold a space in camp. This deposit must be received to secure a space.

Upon receipt of registration, Out of District residents will be put on a waiting list that will be activated on May 25, 2021. A deposit of \$400.00 per camper will hold a space on the waiting list. **Out of district residents must have OPWDD eligibility determination or initiated the process.**



Daily Schedule:

The camp day is divided into 25 minute sessions in the morning, a break for lunch, water activities and more specials. Opening and closing circles for each camp group help the campers adjust to pre-camp and end of camp transition. Careful attention is paid to structure and organizing the day to best meet the needs of each camp group.

Medications:

North East employs a Registered Nurse to coordinate and supervise the control and administration of all camper medication and tend to medical needs. **Please note if your camper takes emergency medications (ie. Seizures) we cannot guarantee our nurse will be present immediately to administer the medications.** Parents are encouraged to discuss their child's health issues with the nurse throughout the six week camp session. Under no circumstances are campers to carry their own medications. Medications must be in to the North East office before June 23, 2021.

Lunch:

Campers should bring a bag lunch and drink. There is no refrigerator or microwave available, so please, pack lunches that do not need refrigeration. **We are nut free! No nuts, peanuts or nut products are allowed on the premises.**

Trips: (Pending DOH approval and change in guidelines)

We provide each camp group with at least one field trip a week. Locations will include such favorites as bowling, nature centers, children's museums, and much, much more. Parents will be informed of trips when camp begins.

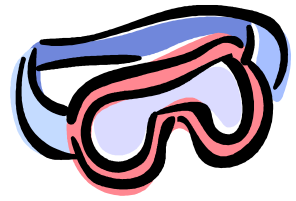
Specials:

Our camp staff includes eight specialists who are responsible for planning specific activities for the campers. Our specials include: **Art, Fitness, Gym, Music, Project Adventure, Nature, Hobbies and Outdoor Games.**

Thanks to our affiliation with the various municipal recreation departments, North East Day Camp is able to use a number of outdoor community pool facilities. Campers will swim every day weather permitting.

A very unique and wonderful compliment to our Day Camp Program is the Bradhurst Outdoor Education Center. Once a week, each camp group will visit Bradhurst to meet the **Nature, Fitness, and Outdoor Art Specialists** for a morning of activities. The children will plant, maintain and harvest our large garden area, learn camping skills that will prepare them for their camp out adventure, and make use of the natural environment to create nature crafts. They will also exercise to stay in shape and have fun.

North East provides an overnight experience for our older camp groups (Eagles and Panthers). The campout would take place at Blue Mt Reservation in Peekskill NY. As of this writing, the park is still closed. **If allowed, the campouts would be July 12-16.**

Transportation: (Pending DOH and Bussing Guidelines)

Bus transportation is provided to and from central pick-up points within our North East district. Out of district pick up will not be provided. Transportation routes and schedules are coordinated by North East staff with the safety of all participants in mind.

Assessment/Placement:

In an effort to provide for an appropriate placement, each child is assessed by a clinical team and placed in one of our camp groups. Groups within our camp are formed with consideration of age and ability. North East reserves the right to change placement as we deem necessary after consultation with all parties involved.

Camp Behavior:

Safety and fun are important elements of North East Camp. Behavior therapists are employed by North East to reinforce positive behavior and present a pleasant experience for all enrolled.

If your son/daughter is identified as one who needs additional support, you will be notified. A meeting will then be scheduled with the behavior therapist and camp director. We have enclosed a copy of our behavior policy which will be enforced by North East staff.

OUR CAMP GROUPS

Roadrunners(Our Youngest Group)

This program provides a structured play environment and social setting for young children who will benefit from sensory exploration, guided physical activity and cognitive stimulation.



Dragons

This program is for children who possess a high level of independence yet require staff guidance and support in improving and refining peer relationships and skill development.

Socialization with fellow campers and expression of one's self are key to building a positive self image.



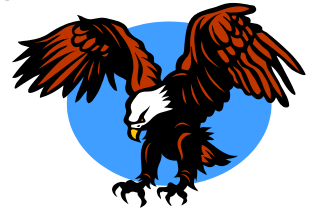
Panthers

This program is for children who possess a high level of independence yet continue to benefit from staff guidance and support. This group will be provided with experiences to encourage increased responsibility and leadership which will prepare them for the transition into our Eagles Group. Opportunities for success and improved self-esteem will be encouraged through program participation.



Eagles (Our Oldest Group)

This program focuses on the enhancement of self esteem and personal growth. Campers participate in the full range of camp activities adapted to offer maximum challenge and success. Responsibility and leadership are introduced and encouraged through team building activities and events, community service projects and staff ratio that will allow campers the opportunity to work towards a level of independence.



North East Westchester Special Recreation, established in the early 1970's is a community based therapeutic recreation agency serving children and adults with developmental disabilities in the North East portion of Westchester County. North East is the second largest agency of its kind in the State of New York and has gained local and state-wide attention for the quality and novelty of programs and services.
